  - Allocated by the WCCTAC Board
  - For capital projects that are part of STMP Project list
- STMP Program Updated in 2019; Cycle 1 was in 2021

- WCCTAC has:
  - \$12,227,074 in STMP
  - \$ 6,391,144 already committed
  - □ \$ 5,835,930 uncommitted
- Staff proposes to make \$5.3M available
  - Leaves funds for administrative costs and STMP Update in next few years
- Confer with TAC in April; then issue Call.
