RE: OBAG 2 and Measure J Funding Recommendation

REQUESTED ACTION

Develop a consensus funding recommendation for the WCCTAC Board.

BACKGROUND AND DISCUSSION

At its March meeting, the WCCTAC Board approved a recommendation for Measure J TLC funding that was developed by the WCCTAC TAC (included as Attachment A). Staff informed the Board that it would need to revisit the issue if more funds became available.

The availability of additional TLC funds was dependent on the outcome of the Measure J PBTF grant process. That process has now concluded and the recommendations for PBTF funding are included as Attachment B.

There was one project, the Plaza San Pablo Greenway Trail, which was recommended in both the WCCTAC TLC process and the PBTF process. The project has an estimated cost of \$1,280,000 and received that full amount in the TLC recommendation. It also is being recommended for \$1,000,000 of PBTF funding. As a result, the project will only need \$280,000 in TLC funding which will free up \$1,000,000 in additional TLC funds to allocate.

WCCTAC staff is seeking to develop a consensus TAC recommendation to present to the WCCTAC Board.

As part of its recommendation, the TAC identified four projects that could receive additional funding as follows:

For its recommendation to the Board, WCCTAC staff added the Rumrill Blvd. Complete Streets Project (Phase II) in the event that more than \$2,308,000 in additional TLC funds became available. Since that did not occur, staff recommends confining the new allocation to the four projects previously identified by the TAC.

There are many ways to allocate these funds. However, given that the 13th Street Complete Streets project is the highest ranking project of the group, staff recommends covering the remaining \$600,000 for that project and allocating the remaining \$400,000 to one or more of the other three projects.

RE Recommendations for Second Cycle PBTF Funding

As part of the Coordinated Call for Projects, the Authority received 27 requests for Measure J Pedestrian, Bicycle and Trail Facilities (PBTF) program funding. Subsequently, the County asked that two of its projects — the Fred Jackson Way and Pacheco Boulevard pedestrian and streetscape improvements — be removed from consideration. The remaining 25 requests totaled between \$19.8 and \$21.2 million, depending on whether the project is requesting PBTF funds with or without OBAG funds as part of its funding plan. About \$7.9 million in PBTF funds is available through the Coordinated Call for Projects.

Because of the number of applications received, they were divided among the CBPAC members for review. No member reviewed a project that their agency sponsored or a project from their subregion. Each application was reviewed by at least four members.

This review resulted in a preliminary ranking and agreement that:

1. The top two most highly-ranked projects would be recommended for funding, and

 the CBPAC would tour the ten or so lower-ranked projects around the funding cut-off line — the lowest-ranked projects would not be visited during the tour — to inform the final ranking

Because reviewers sometimes scored applications quite differently, the CBPAC also asked staff to look at how adjusting scores based on how strict or lenient each reviewer and to use that adjustment to choose which projects would be visited. As a result, staff increased the number of projects to be visited to 13.

The tour took place on March 27, 2017, the date of the regularly-scheduled March CBPAC meeting. Following the tour, the members ranked the projects visited in order of how well those projects met the PBTF criteria. During the tour, CBPAC particularly raised questions about the number of users served, the safety and comfort benefits or the project, and how far along the sponsor is in project design.

The following table shows the project rankings based on the review of the applications and the site visits. If no supplemental funds are available, the PBTF program could fund all or part of nine projects. If some funds are available through the Competitive OBAG, TLC or other programs, some additional projects could also be funded. Trying to maximize the number of projects funded is one of the objectives of the Coordinated Call for Projects.
